Notice of intention to apply to the Environmental Protection Agency for an Industrial Emissions (IE) Licence pursuant to the the Environmental Protection Agency (Industrial Emissions) (Licensing) Regulations 2013, S.I. No. 137 of 2013

To whom it may concern,

Indaver Ireland Limited hereby wishes to notify Cork County Council, as the relevant planning authority for the purposes of the above Regulations, that an application for an Industrial Emissions Licence will be submitted to the Environmental Protection Agency (EPA).

This application is in respect of a Waste to Energy Facility (waste incinerator with energy recovery) at a site in the townland of Ringaskiddy, County Cork (National Grid Ref. E179055, N064279) for the treatment of residual household, commercial and industrial waste which includes up to 24,000 tonnes of suitable hazardous waste with an annual capacity of 240,000 tonnes per annum.

The Classes of Activity at the site as specified in the First Schedule to the Environmental Protection Act of 1992 as amended, are as follows:
Class 11.3(a) Disposal or recovery of waste in waste incineration plants for non-hazardous waste with a capacity exceeding 3 tonnes per hour.
Class 11.3(b) Disposal or recovery of waste in waste incineration plants for hazardous waste with a capacity exceeding 10 tonnes per day.
